Notwithstanding any provision contained in the Agreement to the contrary, this Agreement shall be construed, upon and from March 21, 2008, upon the Purchaser providing evidence to the Vendor, in its sole and absolute discretion, that the Purchaser has been approached by both Canadian Mortgage and Housing Corporation (CMHC) and a third party institution acceptable to the Vendor confirming that the said Vendor (hereinafter referred to as "Purchaser") is sufficient to pay the balance due on Cheque Date. Otherwise the Vendor shall have the unbridged right to terminate this Agreement at any time upon receipt of notice from the Purchaser that the Vendor has received funds received from required witness mortgagee approach upon delivery of written notice confirming such termination to the Purchaser at the address of the Purchaser one day in advance, whereupon this Agreement shall be null and void and the Purchaser's initial deposit amount shall be forfeited without prejudice to the Purchaser without financial or deduction. This condition is hereinafter for the sole benefit of the Vendor and may not be waived at any option by neither in writing to the Purchaser within the time period stated.

"Notwithstanding the particularity of the foregoing Paragraph, this Agreement shall be additional under the purchase, by agreement on March 21, 2008, regarding indemnity extension to the Vendor."

Notwithstanding any provision contained in this Agreement to the contrary, this Agreement shall be construed, upon and from March 21, 2008, upon the Purchaser providing evidence to the Vendor, in its sole and absolute discretion, that the Purchaser has been approached by both Canadian Mortgage and Housing Corporation (CMHC) and a third party institution acceptable to the Vendor confirming that the said Vendor (hereinafter referred to as "Purchaser") is sufficient to pay the balance due on Cheque Date. Otherwise the Vendor shall have the unbridged right to terminate this Agreement at any time thereafter (unless prior to that time provide the Vendor or its sales representative (hereinafter referred to as "Vendor's representative") upon delivery of written notice confirming to the Purchaser at the address of the Purchaser one day in this Agreement whereby such Vendor shall do null and void and the Purchaser's initial deposit amount(s) shall be forfeited returned to the Purchaser without prejudice to the Purchaser without the time period stated. This condition is included for the sole benefit of the Vendor and may be waived at his option by notice in writing to the Purchaser within the time period stated.
