(b) None of the Related Purchasers being in default, at any time, under any of the Agreements of Purchase and Sale pertaining to the Related Transactions.

Notwithstanding anything contained herein, the Vendor's obligation to provide the Finishes and Extras, Assignment, and Leasing Addendums is personal in nature to the Purchaser and in the event that the Related Purchasers default, at any time, his/her interest in the Unit or in the Agreement of Purchase and Sale prior to the Occupancy Date then such Addendums shall also be deemed to be null and void and without limiting anything contained herein the Vendor will not agree to the above Finishes and Extras, Assignment, and Leasing Addendums.
