APPENDIX TO THE AGREEMENT OF PURCHASE AND SALE

The Purchaser acknowledges that the Furniture Package will be delivered within 30 days of Interim Occupancy and is conditioned upon full deposits payable by the Purchaser under this Agreement which are due as of the commencement date of the Interim Occupancy having been received by the Vendor's Escrow Agent's Trust Account. The Purchaser agrees to coordinate the delivery of the Furniture Package through the Vendor's designate. The Purchaser further acknowledges that it is not a condition of closing that the Furniture Package be available on the date of occupancy or final closing. The Purchaser not a condition of closing that the Furniture Package be available on the date of occupancy or final closing. The Purchaser agrees to complete the transaction notwithstanding the availability of the Furniture Package (or any portions or components thereof) without any hold back or claim or reservation of claim for breach of contract.

1. The Purchaser shall have the right to exchange other products and materials for those listed in this Addendum (including, without limitation, items comprising 10% of the purchase price) provided that (i) the Vendor's opinion, that such exchanged products are of a quality equal to or better than the products and materials so listed on the Addendum, (ii) the Purchaser has given notice to the Vendor in writing with respect to products, words and estimates as the case may be that all products are not acceptable to the Purchaser, (iii) the Purchaser has given the Vendor 30 days to make arrangements to replace the products and materials so listed at the Purchaser's request.
 2. The Vendor is not responsible for damage, difficulties occurring from different causes to furniture which may be found in the unit at the time of the Furniture Package.
 3. The Purchaser acknowledges that there shall be no reduction or credit given of the purchase price for any damage listed herein which occurred at the Purchaser's request.
 4. References to model lines or model numbers refer to current manufacturer's models. If these types or models change, the Vendor shall provide an equivalent or better model. In the Vendor's opinion, the substituted products and materials are of a quality equal to or better than the products and materials so listed or so provided.
 5. All dimensions, if any, are approximate.
 6. All specifications and materials are subject to change without notice.
 7. Final and specific figures will depend on the Vendor's packages as selected.
- The Vendor's obligation to provide the Furniture Package is conditioned to the Purchaser and to not be enforceable or assignable and shall automatically terminate without notice or any further process if the Purchaser fails to pay any amounts due under this Agreement (or any interest thereon) or fails to pay any amounts due under any other agreement between the Vendor and Purchaser, and without limiting anything contained herein, (i) any provisions of the Purchase Agreement shall automatically terminate without notice or any further process if the Purchaser defaults in any of the provisions of this Agreement and the Purchaser fails to cure such defects as specified in this Agreement, (ii) the Vendor's obligation to provide the Furniture Package is conditioned upon all documents payable by the Purchaser under this Agreement having been received by the Purchaser in the Vendor's Escrow Agent's Trust Account.
8. The Purchaser acknowledges that the Vendor is acting merely as agent of the various manufacturers with respect to such specific furniture and subsequently each manufacturer's vendor shall be responsible for any damage to such furniture and shall be liable for any damage to such furniture. The Purchaser shall not be liable for any damage to such furniture.
9. The Purchaser acknowledges that the Vendor is selling "AS IS" within the understanding of the Purchaser that the Purchaser is buying the furniture for its own use and is not a reseller for profit, quality, durability or any other reason. The Purchaser hereby releases the Vendor from any such claims and acknowledges that the Vendor is liable for defective or faulty parts or solely to the manufacturers or suppliers of the Purchaser, and not the Vendor.
