The Purchaser agrees to coordinate the delivery of the Furniture Package through the Vendor's designate. The Purchaser further acknowledges that it is not a condition of closing that the Furniture Package be available on the date of occupancy or final closing. The Purchaser covenants and agrees to complete the transaction notwithstanding on availability of the Furniture Package (or any portions or portion thereof) without any hold back or claim or reservation of claim for breach of contract.
