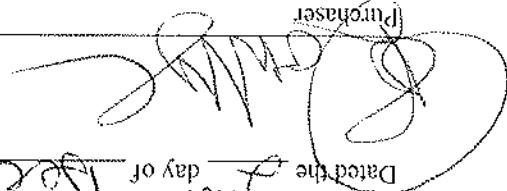


ACCESS AGREEMENT FOR SERVICE WORK
