


If the Vendor is unable to supply any of the above noted selections, the Purchaser will at the request of the Vendor choose alternative selection from the Vendor's Samples within seven (7) business days then business days of being notified by the Vendor to do so, if the Purchaser does not reselect within such seven (7) business days then the Vendor will make such selections for the Purchaser.
- O, At such time as the Vendor or its Sales Representatives notifies the Purchaser as to the cost(s), the Purchaser shall pay said amount to the Vendor, within seven (7) business days from being so notified.
