(v) the sum of Thirty One Thousand Five Hundred Ninety (\$31,590.00) Dollars so as to bring the total of the deposits set out in subparagraph 1(a)(i), (ii), (iii), (iv) and (v) to twenty five (25%) percent of the Purchase Price on the Occupancy Date (as same may be extended in accordance herewith);

(vi) the sum of Fifteen Thousand Seven Hundred Ninety Five (\$15,795.00) Dollars so as to bring the total of the deposits set out in subparagraph 1(a)(i), (ii), (iii), (iv), (v) and (vi) to twenty (20%) percent of the Purchase Price on the Occupancy Date (as same may be extended in accordance herewith);
