AMENDMENT TO AGREEMENT OF PURCHASE AND SALE

Between: AMACON DEVELOPMENT (CITY CENTRE) CORP. (the "Vendor") and

MARIBEL CARBAJAL HERNANDEZ (the "Purchaser")

It is hereby understood and agreed between the Vendor and the Purchaser that the following change(s) shall be made to the above-mentioned Agreement of Purchase and Sale, and except for such change(s) noted below, all other terms and conditions of the Agreement shall remain as stated therein, and time shall continue to be of the essence.

DELETE: FROM THE AGREEMENT OF PURCHASE AND SALE (in Amendment to Agreement of Purchase and Sale - Deposit, signed on 8 September 2012)

(iv) the sum of Fifteen Thousand Six Hundred Ninety Five (\$15,695.00) Dollars so as to bring the total of the deposits set out in subparagraphs 1(a)(i), (ii), (iii) and (iv) to fifteen (15%) percent of the Purchase Price submitted with this Agreement and post dated two hundred and seventy (270) days following the date of execution of this Agreement by the Purchaser, and

(v) the sum of Sixty Two Thousand Seven Hundred Eighty (\$62,780.00) Dollars so as to bring the total of the deposits set out in subparagraphs 1(a)(i), (ii), (iii), (iv) and (v) to thirty five (35%) percent of the Purchase Price on the Occupancy Date (as same may be extended in accordance herewith).

INSERT: TO THE AGREEMENT OF PURCHASE AND SALE

(iv) the sum of Fifteen Thousand Six Hundred Ninety Five (\$15,695.00) Dollars so as to bring the total of the deposits set out in subparagraphs 1(a)(i), (ii), (iii) and (iv) to fifteen (15%) percent of the Purchase Price submitted with this Agreement and post dated two hundred and seventy (270) days following the date of execution of this Agreement by the Purchaser,

(v) the sum of One Hundred Thousand (\$100,000.00) Dollars so as to bring the total of the deposits set out in subparagraphs 1(a)(i), (ii), (iii), (iv) and (v) to forty six (46%) percent of the Purchase Price submitted with this Agreement and post dated five hundred and fifteen (515) days following the date of execution of this Agreement by the Purchaser, and

(vi) the sum of Sixty Two Thousand Seven Hundred Eighty (\$62,780.00) Dollars so as to bring the total of the deposits set out in subparagraphs 1(a)(i), (ii), (iii), (iv), (v) and (vi) to sixty six (66%) percent of the Purchase Price on the Occupancy Date (as same may be extended in accordance herewith).
