(v)the sum of Thirty Thousand Ninety (30,090.00) Dollars so as to bring the total of the deposits set out in subparagraph 1(a)(i), (ii), (iii), (iv) and (v) to twenty five (25%) percent of the Purchase Price) on the Occupancy Date (as same may be extended in accordance herewith);

(v)the sum of Fifteen Thousand Forty Five (\$15,045.00) Dollars so as to bring the total of the deposits set out in subparagraph 1(a) (i), (ii), (iii), (iv) and (v) to twenty ~~five~~ ^{20%} (25%) percent of the Purchase Price) on the Occupancy Date (as same may be extended in accordance herewith);
