 - vii. the sum of Thirteen Thousand Eight Hundred Ninety-Five (\$13,895.00) Dollars so as to bring the total of the deposits set out in subparagraph "i" and letter "D" a hundred twenty ("120") percent of the Purchase Price on the Occupancy Date or earlier if agreed to in accordance herewith.

 - h) the sum of Thirteen Thousand Eight Hundred Ninety-Five (\$13,895.00) Dollars so as to bring the total of the deposits set out in subparagraphs 1(a)(ii), (iii) and (iv) to fifteen (15%) percent of the Purchase Price submitted with this Agreement and due date of three hundred and sixty five (365) days following the date of execution of this Agreement by the Purchaser; and
 - i) the sum of Fifty Five Thousand Five Hundred and Eighty (\$55,580.00) Dollars so as to bring the total of the deposits set out in subparagraph 1(a)(v) to one (1) and one thirty five (35%) percent of the Purchase Price on the Occupancy Date (as such term may be defined in accordance herewith).
