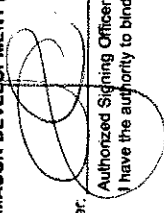
AMENDMENT TO AGREEMENT OF PURCHASE AND SALE

a(v) The sum of Seventeen Thousand Six Hundred Twenty (\$17,620) Dollars so as to bring the total of the deposits set out in subparagraphs 1 (a) (i), (ii), (iii), (iv) and (v) to twenty percent (20%) of the Purchase Price on the Occupancy Date (as same may be extended in accordance herewith);

INSERT: TO THE AGREEMENT OF PURCHASE AND SALE
(iv) the sum of Eight Thousand (\$8,000.00) Dollars shall be submitted by certified cheque on or before May 24, 2018 by the Purchaser;
(v) the sum of Nine Thousand Six Hundred Twenty (\$9,620.00) Dollars shall be submitted by certified cheque on or before August 24, 2018 by the Purchaser;
(vi) The sum of Seventeen Thousand Six Hundred Twenty (\$17,620) Dollars so as to bring the total of the deposits set out in subparagraphs 1 (a) (i), (ii), (iii), (iv) and (v) to twenty percent (20%) of the Purchase Price on the Occupancy Date (as same may be extended in accordance herewith);
