INSERT:

- (ii) the sum of **Thirty-Two Thousand Four Hundred Forty-Five (32,445.00)** Dollars so as to bring the total of the deposits set out in subparagraphs 1(a)(i) and (ii) to five (5%) percent of the Purchase Price submitted with this Agreement and post dated thirty (30) days following the date of execution of this Agreement by the Purchaser;
- (iii) the sum of **Eighteen Thousand Seven Hundred Twenty Two Dollars and Fifty Cents (18,722.50)** so as to bring the total of the deposits set out in subparagraphs 1(a)(i), (ii) and (iii) to seven and a half (7,5%) percent of the Purchase Price submitted with this Agreement and post dated one hundred and eighty (180) days following the date of execution of this Agreement by the Purchaser;
- (iv) the sum of **Eighteen Thousand Seven Hundred Twenty Two Dollars and Fifty Cents (18,722.50)** Dollars so as to bring the total of the deposits set out in subparagraphs 1(a)(i), (ii) and (iii) to ten (10%) percent of the Purchase Price submitted with this Agreement and post dated three hundred and sixty five (365) days following the date of execution of this Agreement by the Purchaser;
