





Dear MOHAMMAD SHAHROUR:

This letter concerns your application for a permanent resident (PR) card.

In order for IRCC to determine if the PR card that was created for you has the appropriate period of validity and can be distributed to you, or if a PR card of a different validity period should be prepared and issued to you, your attendance is required, as per subsection <u>58(3)</u> of the *Immigration and Refugee Protection Regulations* (IRPR):

- 2. To enter Etobicoke IRCC, you must bring:
  - this letter, and
  - photo identification (or other documents proving your identity matches the name on this notice).
- Pursuant subsection <u>58(4)</u> of IRPR, bring all the original documents that you included as copies in your application as required by paragraphs <u>R56(2)(c)</u> and (d) of IRPR.
  - Failure to do so may result in the card not being provided to you, pursuant to subsection 58(4) and paragraph 59(1)(c) of IRPR.
  - If you did not return your PR card with your application, you are requested to bring it with you
    to this appointment.

Due to Health Canada restrictions, space capacity in our office is limited. <u>Due to this limitation, NO walk-ins or unscheduled appointments will be permitted.</u>

Accordingly, you must arrive on time for your appointment. If you fail to arrive on time, your appointment may be cancelled. You should not arrive more than 15 minutes before your appointment. Please present a copy of this letter upon your arrival. Be prepared to spend up to an hour in the office.

In order to respect physical distancing and the maximum allowed capacity in our waiting rooms, only the individual stipulated on this letter is to appear to pick-up their PR card. Clients' representatives or family members will not be allowed to accompany them to their appointment. However, representatives and interpreters will be able to join by phone.

Anyone entering the office space is required to wear a mask or face covering. You are not permitted to attend your appointment if you are feeling unwell or experiencing any COVID symptoms. Visit the Health Canada website and complete the self-assessment tool <a href="https://www.thrive.health/health-canada-self-assessment-tool">https://www.thrive.health/health-canada-self-assessment-tool</a> before your appointment.





Cancellation/Rescheduling of appointments: If there are compelling reasons why you and/or your dependents are unable to attend (e.g. you or your family member are ill, you have been asked to self-isolate, are outside Canada, etc.) please notify this office by e-mail at <a href="CIC-Etobicoke-PRCD-DCRP@cic.gc.ca">CIC-Etobicoke-PRCD-DCRP@cic.gc.ca</a> in advance of the appointment date with an explanation and your UCI number. To be fair to all applicants awaiting service, appointments will only be rescheduled when there are extenuating circumstances. We will review your submission and advise by e-mail whether we are able to accommodate your request to reschedule.

You may be asked questions in relation to your residency so the officer may determine whether to issue you a PR card valid for 5 years or a PR card valid for one year, per section 54 of IRPR. A PR is required to comply with the residency obligation with respect to every five-year period, per the *Immigration and Refugee Protection Act* (IRPA), section 28, and as a result of your application for a PR card, an IRCC officer is authorized to proceed with an examination, per IRPA, subsections 15(1) and 16(1.1). For that reason, we recommend that you bring supporting documents - please refer to the Annex.

If you require interpretation, please have them available over the phone.

If you do not appear for your final notice appointment, your PR card may be destroyed when the 180-day compliance period has lapsed, as per IRPR, subsection 58(3).

As a result, you would need to submit a new application and fee should you wish to apply for a permanent resident card in the future.

If you are not currently in Canada, you may need to make an application for a permanent resident travel document (PRTD) at the nearest Visa Application Centre or Canadian Visa Office. To find information on how to apply for a PRTD, go to:

#### **Annex - Supporting Documents**

You may be asked to provide proof of your compliance with the residency obligation. Therefore, you are requested to bring with you the following **original documents**:

- All passports and travel documents held by you, used to enter or leave Canada or other countries, whether valid or expired.
- Record of Landing / Confirmation of Permanent Residence.
- · Photo identification
- Expired PR Card
- Proof of residence in Canada for the <u>5 years</u> prior to the date you applied
- Total of all absences from Canada (for the 5 years prior to the date you applied)
- Any documentary proof of your establishment and ties in Canada, which may include:
  - Employment records (for example T-4's, employment letters and other work records).
    - o Schooling/training (for example reports cards, diplomas, awards).
    - Social and community involvement (for example proof of any community involvement, volunteer duties).
    - Medical records (for example proof of hospitalization, medical appointments).
    - Home/family ties (for example rental and mortgage documents, whereabouts of family members).
- Any other information and evidence you have which demonstrates that you meet the residency requirements as prescribed in 28(2) of the *Immigration and Refugee Protection Act*, including information about any humanitarian and compassionate factors you would like considered. Detailed supporting evidence is required.
- Minors under age 14 must be accompanied by a parent or legal guardian with a birth certificate and/or legal guardianship papers;
- Spouses of Canadian Citizens should bring marriage certificate (with translation) and copy of spouse's Canadian passport.

#### Translation:

All documents must be accompanied by an official translation if they are in a language other than English or French. For more information on the translation of documents, you may refer to the Instruction Guide (IMM 5445) of the PR card application available at our external website.


