

The Purchaser acknowledges and agrees that the Vendor's obligation to install the chosen finishir

selections is conditional and subject to the following terms and conditions.

Where the Purchaser has made Upgrade selections or requested changes that are subject to additional charge, and provided the Vendor or its Sales Representative has notified the Purchaser of its agreement to complete same and the cost(s) for such Upgrade or change request, the Purchaser shall pay the total amount owing by certified cheque to the Vendor within seven (7) business days from being so notified.
