And the following shall be inserted in its place:

g) the sum of (\$14,255.00) Fourteen Thousand Two Hundred Fifty-Five And Xx / 100 Dollars by cheque payable to McMillan LLP, in trust, accompanying this Purchase Agreement and post-dated to August 30, 2023 (and representing 2.0% of the Purchase Price), as a further deposit pending completion or other termination of this Purchase Agreement and to be credited on account of the Purchase Price on the Closing Date;
