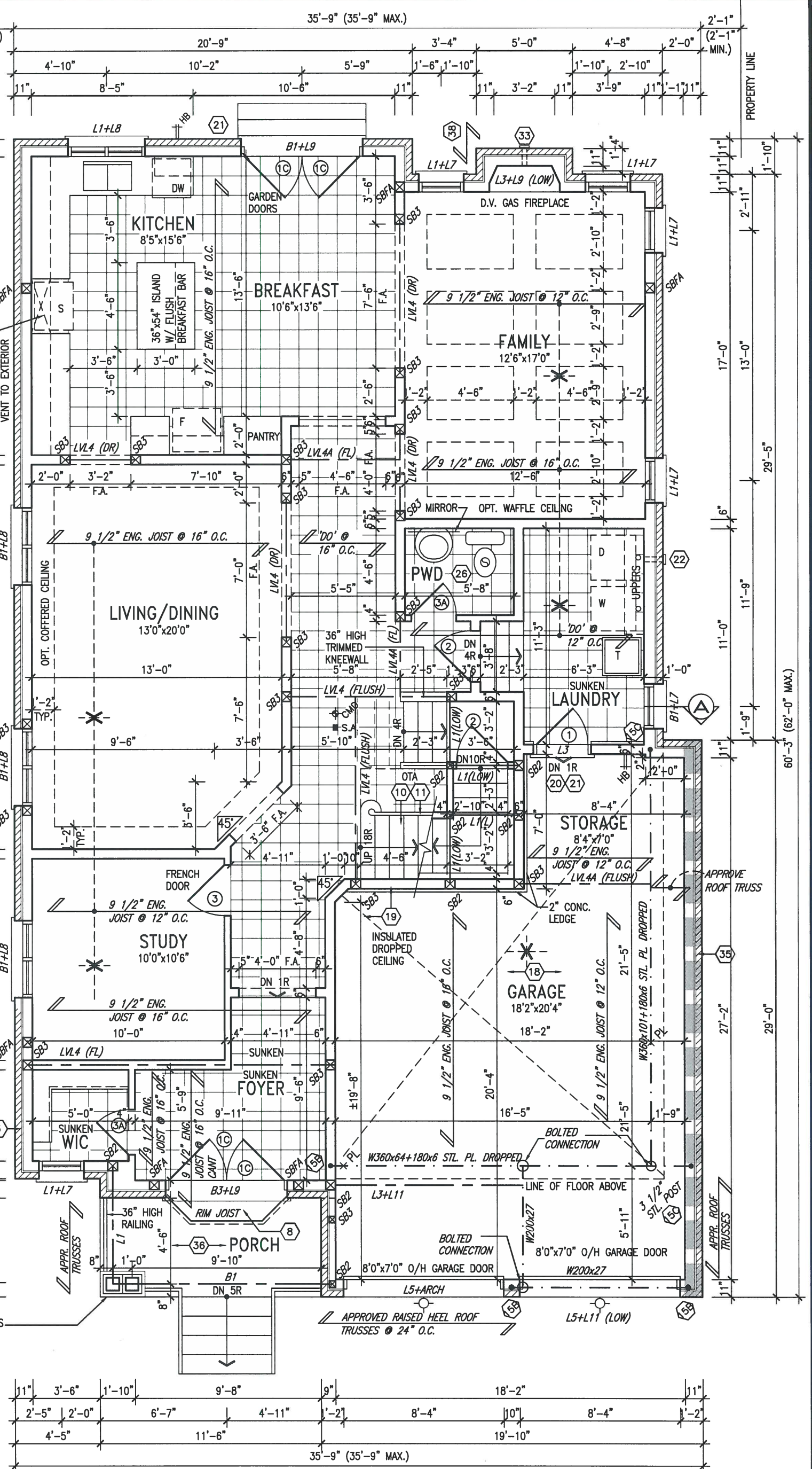

INDICATES FIRE RATED WALL ASSEMBLY

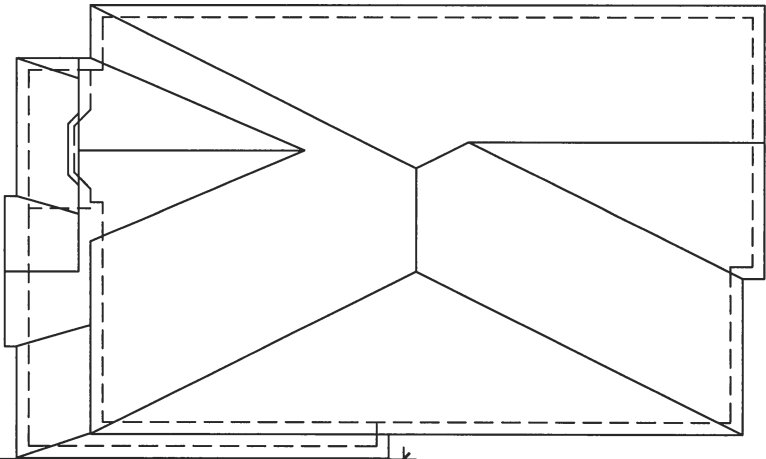

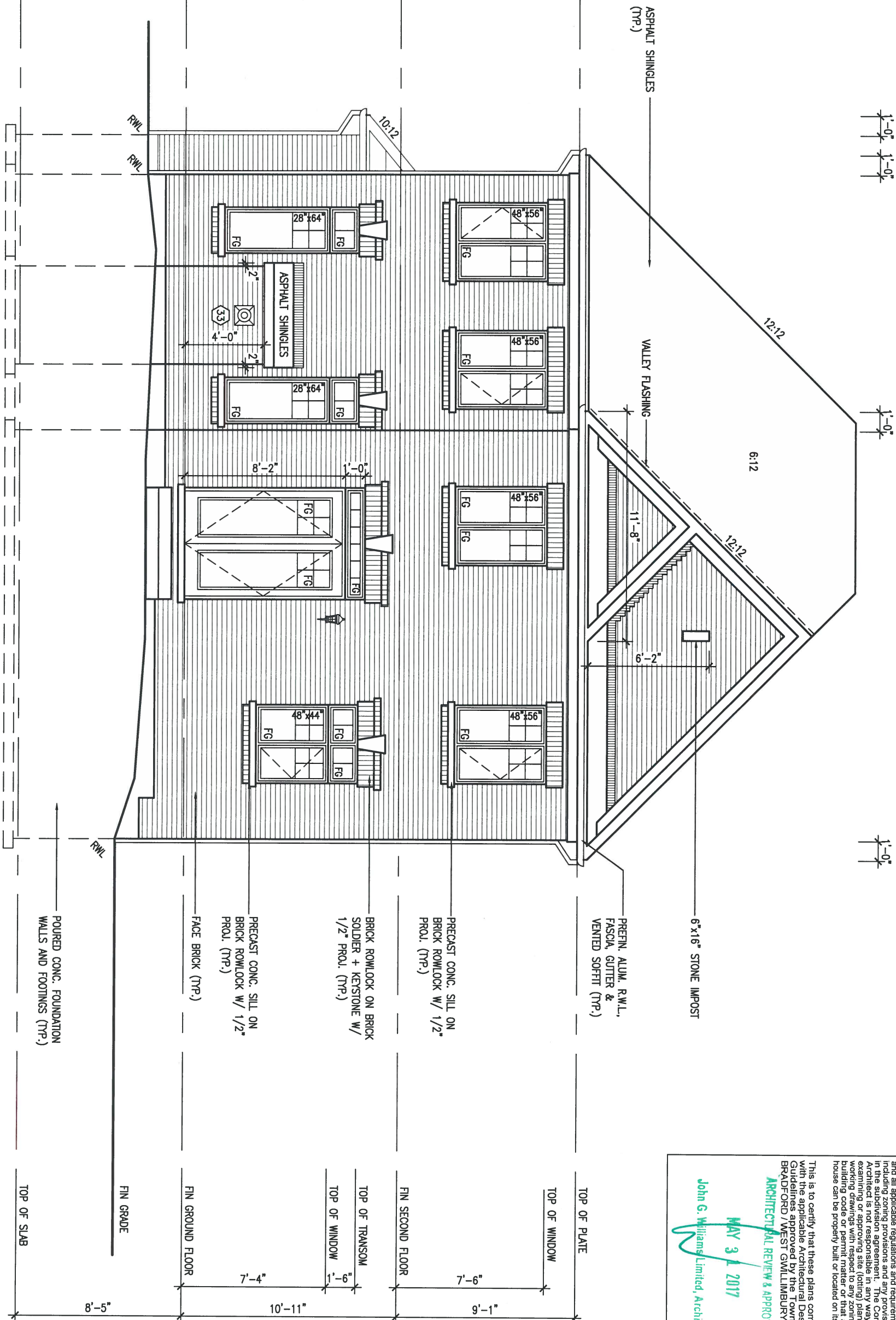
