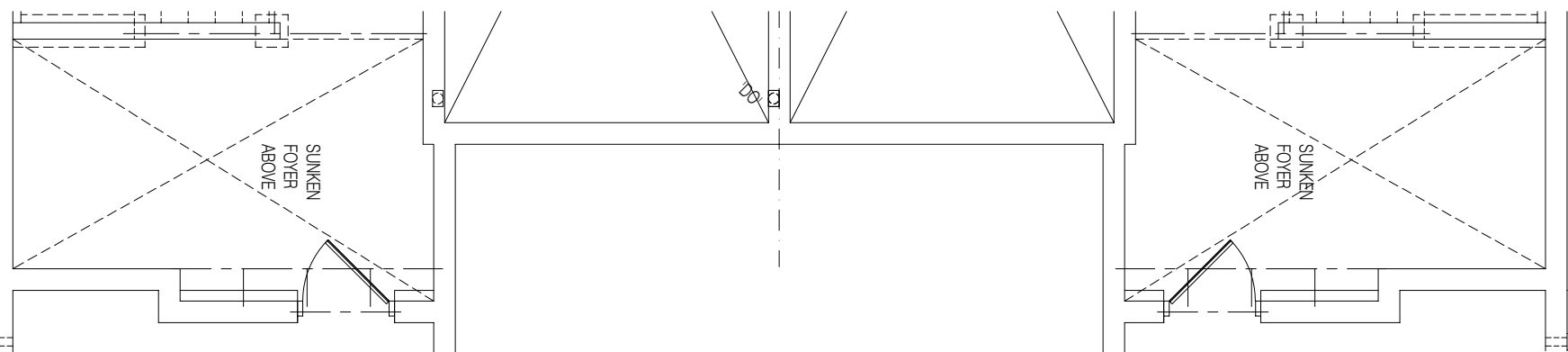
PARTIAL WALK-OUT BASEMENT PLAN

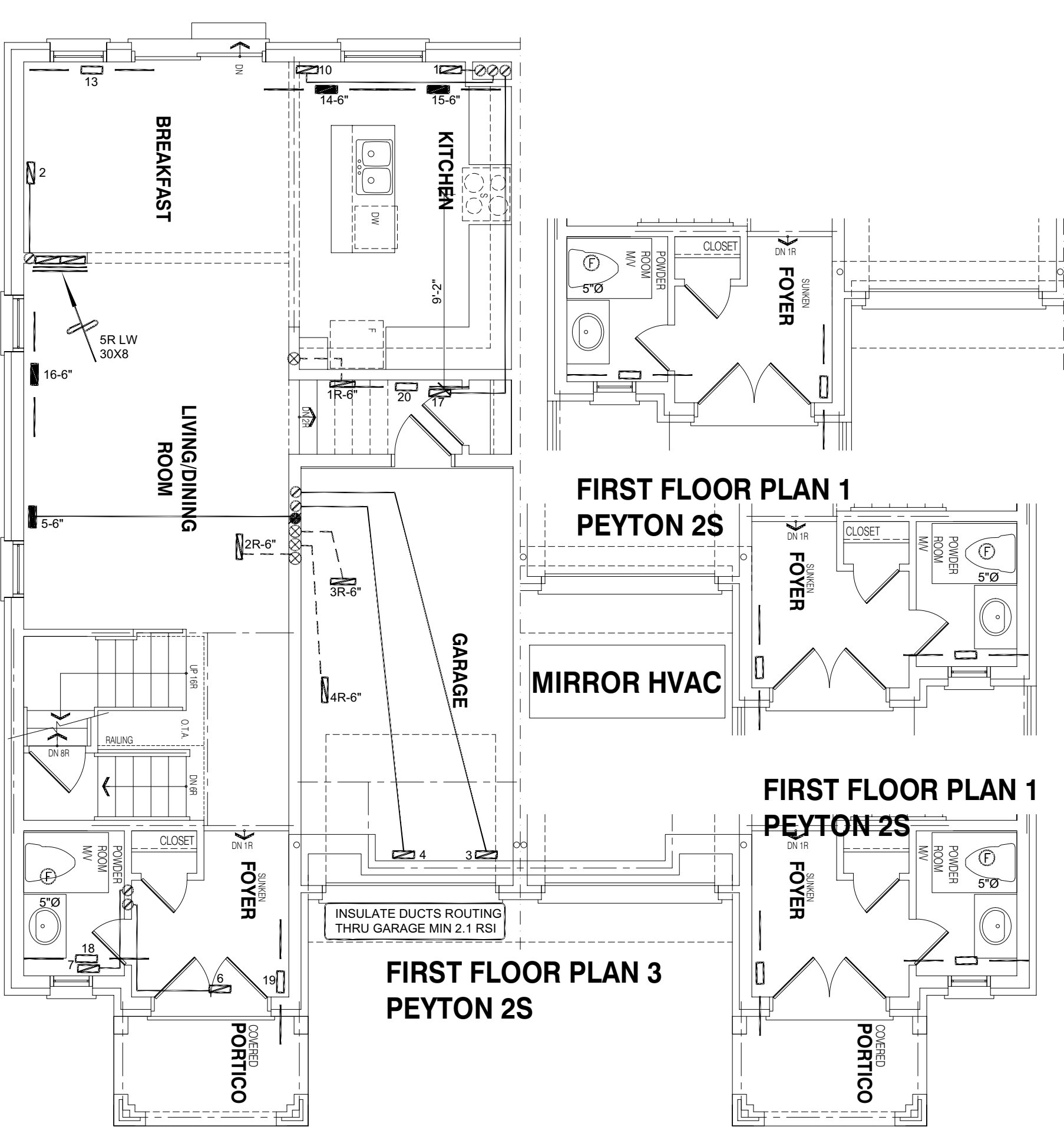

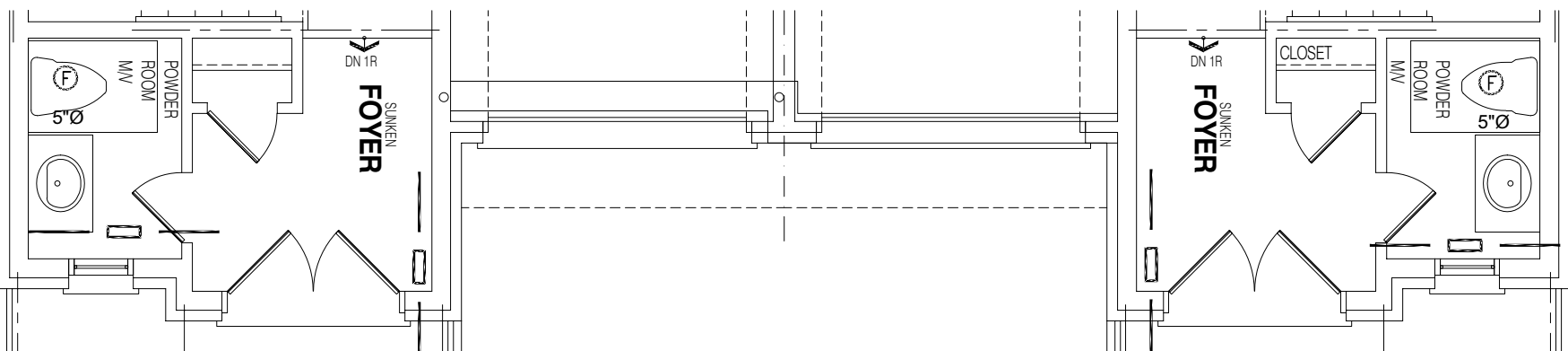


FIRST FLOOR PLAN 1

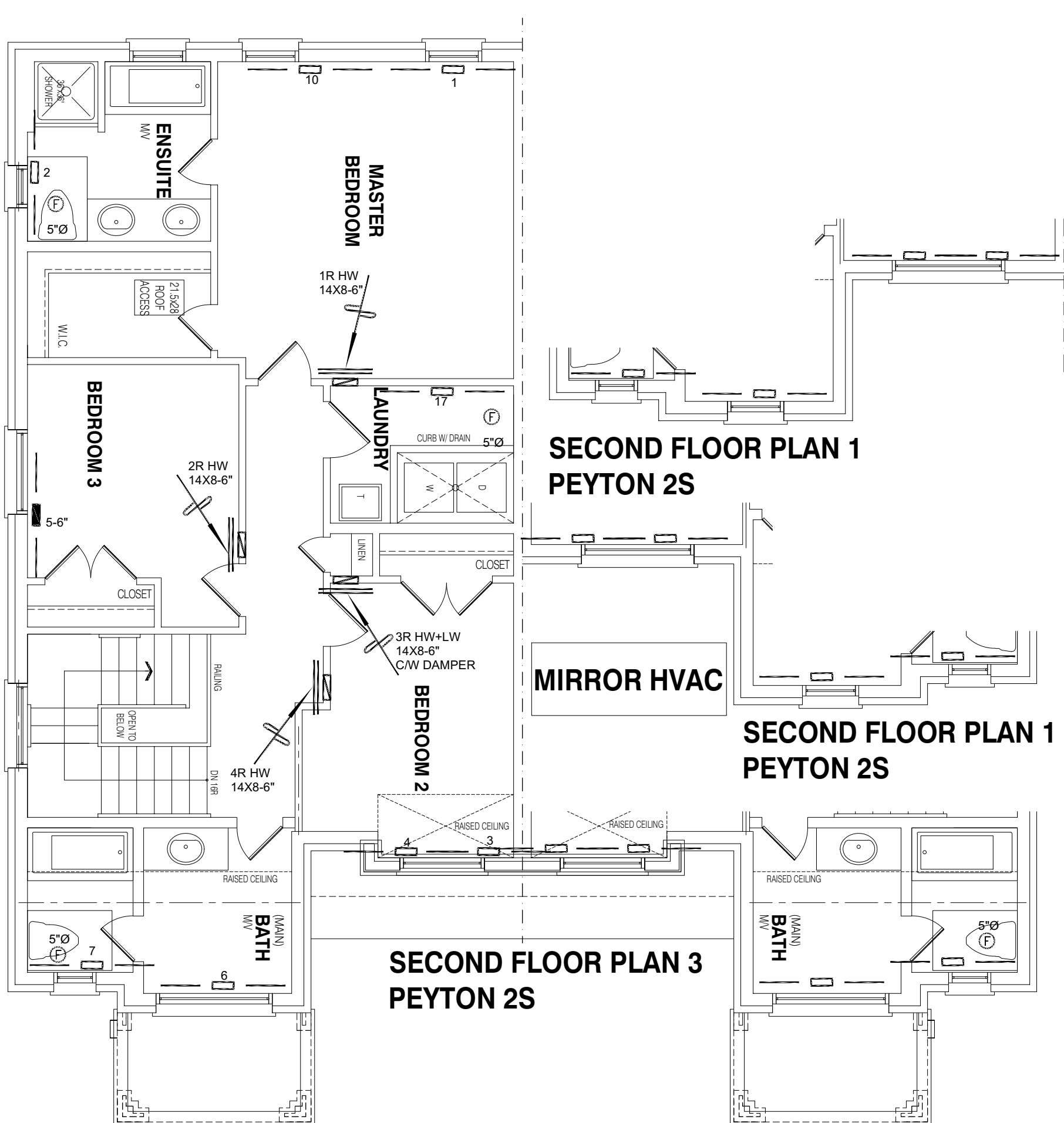

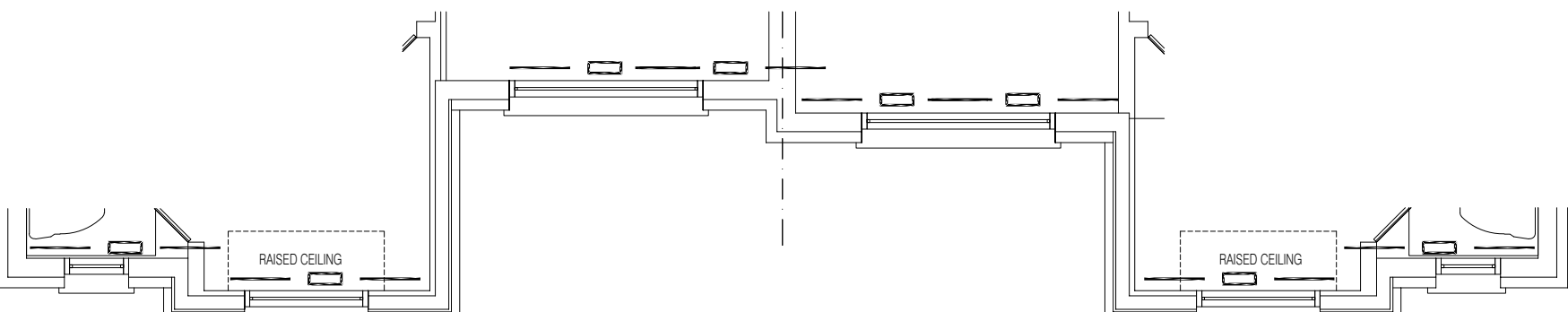
