No person shall occupy, or use, or permit to be occupied or used, any building or part thereof for which a building permit has been issued until notice of the date of its completion is given to the Chief Official.  
This permit is issued under the authority of the BUILDING CODE ACT which states "No person shall construct or cause to be constructed a building in a municipality except in accordance with the plans, specifications, documents and any other information on the basis of which a permit was issued or any changes thereto authorized by the Chief Building Official."

This permit conveys no right to occupy any street or sidewalk or any part thereof either temporarily or permanently. Encroachments on public property not specifically permitted under the Building Code must be approved by the Commissioner of Transportation and Works. Street or lot grades as well as depth and location of public sewers may be obtained from the Transportation and Works Department. The issuance of this permit does not release the Permit holder from the conditions of any applicable subdivision restrictions.

*THIS PERMIT, AMONGST OTHER GROUNDS, IS SUBJECT TO REVOCATION IF CONSTRUCTION OR DEMOLITION IS NOT STARTED WITHIN SIX MONTHS FROM THE DATE OF ISSUANCE OR IF CONSTRUCTION HAS BEEN DISCONTINUED FOR MORE THAN ONE YEAR.*
