2.	Provide and install level 3 floor tiles in the foyer and kitchen/brekfast area area in lieu of level 1 floor tiles. *Note tiles to be installed stacked	
3.	Provide provisions to accommodate a microwave shelf at base cabinet in island to include dedicated electrical and pull-out drawer below.	
4.	Provide and install option 1A hardwood floors at upper hallway *ONLY* on second floor in lieu of level 1 carpet	
5.	Provide and install level 4 interior railing from main to second floor in lieu of level 1
