

AMENDMENT TO THE AGREEMENT OF PURCHASE AND SALE
(the "Amending Agreement")

BETWEEN: QUEENSWELL LTD. (the “Vendor”) and
Kamaljit Kaur Cheema (the “Purchaser”)

WHEREAS:

- A. The Purchaser and the Vendor have entered into a purchase agreement, dated MAY 31, 2021, (the “**Purchase Agreement**”) in respect of the purchase, by the Purchaser from the Vendor, of Unit 1, Level 7, Suite 701, (together with 2 Parking Unit(s) and 0 Storage Unit(s)) (the “Unit”) in a proposed standard condominium plan, Toronto, Ontario (the “Condominium”), all as more particularly described in the Purchase Agreement;
- B. The Purchaser and the Vendor wish to amend certain provisions of the Purchase Agreement; and
- C. Any capitalized terms used but not defined herein shall have the meaning attributed thereto in the Purchase Agreement.

NOW THEREFORE, in consideration of the sum of Two Dollars (\$2.00) paid by each party to the other, the mutual covenants and agreements contained herein, and such other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by each party to the other, the parties hereby agree with the other as follows:

1. It is hereby understood and agreed between the Vendor and the Purchaser that the following change(s) shall be made to the Purchase Agreement, and except for such change(s) noted below in this Section 1, all other terms and conditions of the Purchase Agreement shall remain as stated therein, and time shall continue to be of the essence.

DELETE:

- (xiii) **Seven Thousand Five Hundred Dollars (\$7,500.00)** by cheque post-dated 13 months (**June 30, 2022**) following the date of execution of this Agreement by the Purchaser;
- (xiv) **Seven Thousand Five Hundred Dollars (\$7,500.00)** by cheque post-dated 14 months (**July 31, 2022**) following the date of execution of this Agreement by the Purchaser;
- (xv) **Seven Thousand Five Hundred Dollars (\$7,500.00)** by cheque post-dated 15 months (**August 31, 2022**) following the date of execution of this Agreement by the Purchaser;
- (xvi) **Seven Thousand Five Hundred Dollars (\$7,500.00)** by cheque post-dated 16 months (**September 30, 2022**) following the date of execution of this Agreement by the Purchaser;
- (xvii) **Seven Thousand Five Hundred Dollars (\$7,500.00)** by cheque post-dated 17 months (**October 31, 2022**) following the date of execution of this Agreement by the Purchaser;
- (xviii) **Eight Thousand Nine Hundred Ninety Eight And 50 / 100 Dollars (\$8,998.50)** by cheque post-dated 18 months (**November 30, 2022**) following the date of execution of this Agreement by the Purchaser;
- (xix) **Seventy-Four Thousand Nine Hundred Ninety-Nine And 50 / 100 Dollars (\$74,999.50)** (being **5.0%** of the Purchase Price) by cheque on the Occupancy Date;
- (c) the balance of the Purchase Price by the Purchaser's solicitor's certified cheque (unless otherwise advised pursuant to the Section titled "Tender" in Schedule "E" hereto), subject to adjustments as provided in this Agreement on the Unit Transfer Date (as hereinafter defined).

INSERT:

- (xiii) **Forty Six Thousand Four Hundred Ninety Eight And 50 / 100 Dollars (\$46,498.50)** by cheque post-dated 445 days (**September 30 2022**) following the date of execution of this Agreement by the Purchaser;
- (xiv) **Seventy-Four Thousand Nine Hundred Ninety-Nine And 50 / 100 Dollars (\$74,999.50)** (being **5.0%** of the Purchase Price) by cheque on the Occupancy Date;
- (c) the balance of the Purchase Price by the Purchaser's solicitor's certified cheque (unless otherwise advised pursuant to the Section titled "Tender" in Schedule "E" hereto), subject to adjustments as provided in this Agreement on the Unit Transfer Date (as hereinafter defined).
- 2.** This Amending Agreement may be executed in one or more counterparts, each of which when so executed shall constitute an original, and all of which shall together constitute one and the same Amending Agreement.
- 3.** Each Party to this Amending Agreement may execute a facsimile copy, computer scanned copy or electronically signed copy hereof and each party to this Amending Agreement shall accept a facsimile, computer scanned or electronically signed copy hereof as an originally executed copy hereof.
- 4.** This Amending Agreement is or may be electronically signed pursuant to the Electronic Commerce Act (Ontario), as amended.
