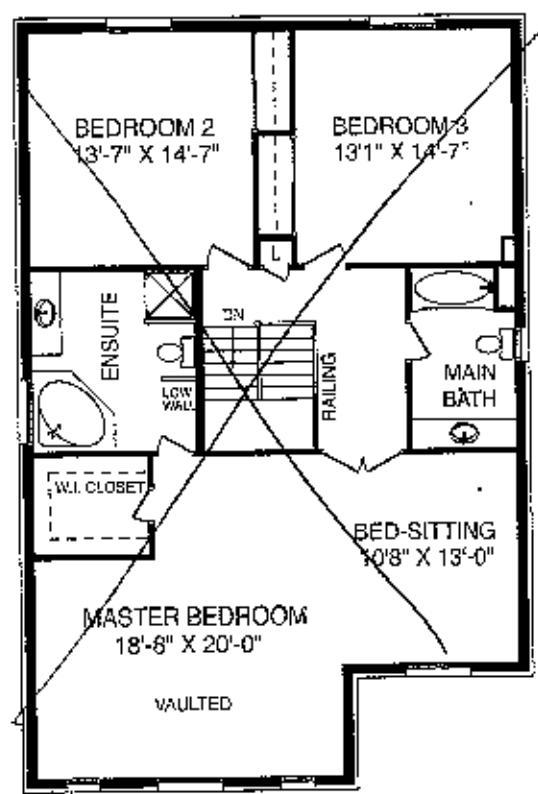

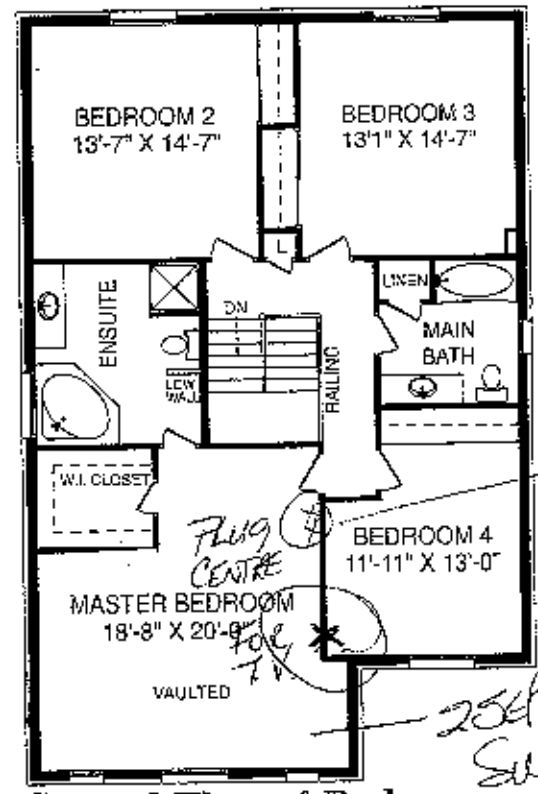

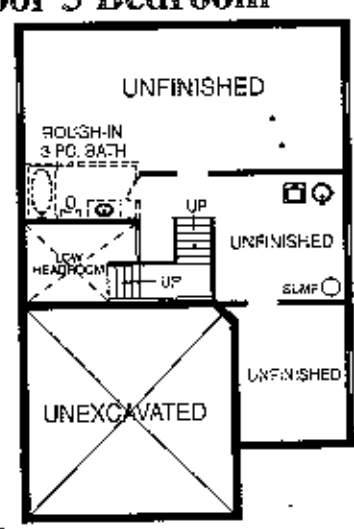
Elevation "A"



Second Floor 3 Bedroom



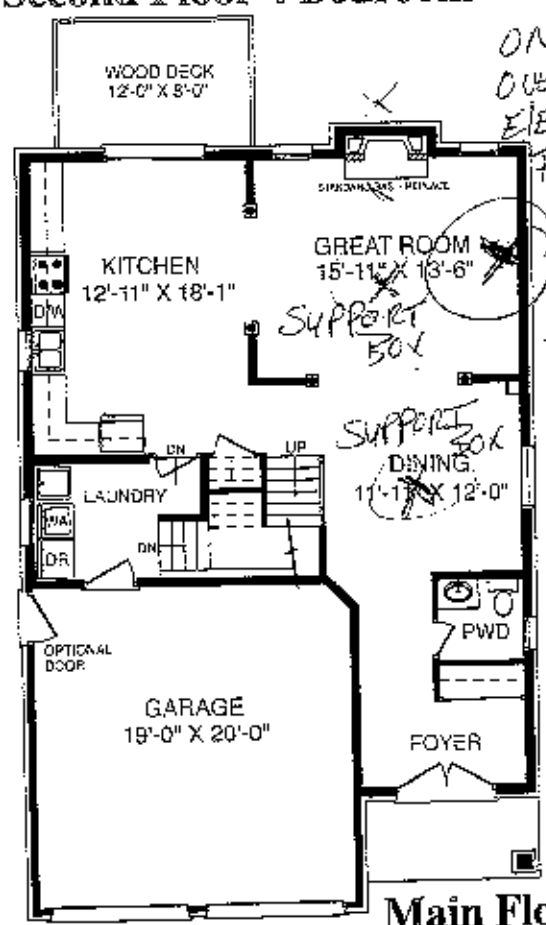
Second Floor 4 Bedroom
