Good Afternoon Ariel,

The Price in Quote SS751 at \$449.00 was for the T5 Under Cabinet Lighting sold. Then we were asked to Upgrade the Under Cabinet Lighting to LED Stick Lights.

The cost for these LED Stick Lights would have been \$587.00 but since there was already a charge of \$449.00 on the Sales Quote (SS751), I requested an additional line on the PO for the additional cost to Upgrade to the Sticks \$138.00. The LED Stick Lighting is more expensive than the T5 Lighting.

The Pricing on the Sale (SS751) never changed as it had already been approved and I believe the decision to install LED Stick Lights in lieu of the sold T5 Under Cabinet Lighting was made by Valecraft and not the homeowners.

To conclude, the Sale should remain at \$977.00 on the PO and we should also have an additional line on the PO for the \$138.00 Upgrade to Stick Lights.


