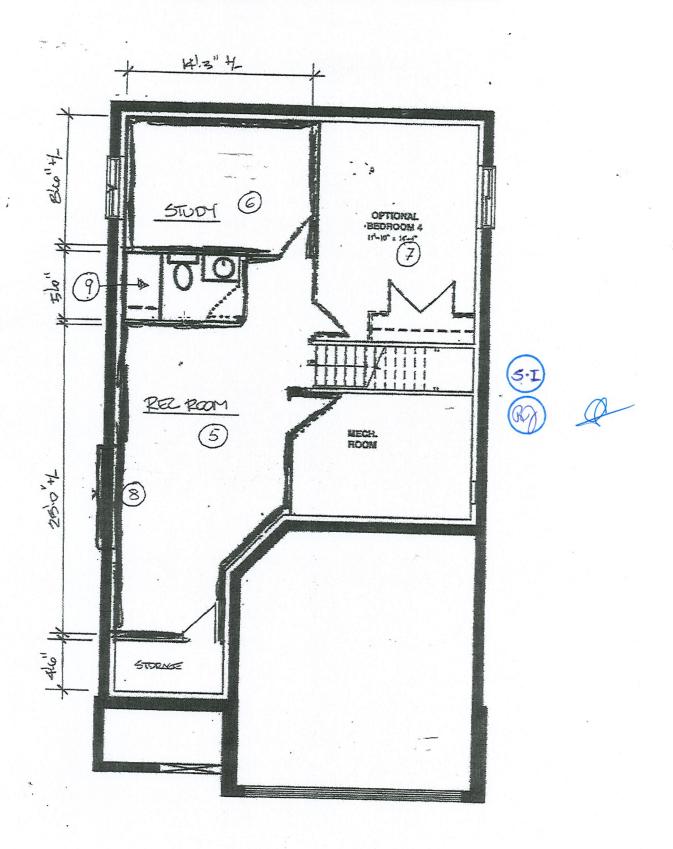








BASEMENT SKETCH - MAY 1, 2021

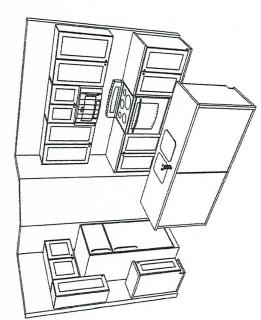
